ASSEMBLY MILITARY AND VETERANS AFFAIRS ALL ASSEMBLY BILLS YEAR END 2023-24 CALIFORNIA STATE LEGISLATIVE SESSION

AB 322 (Mathis) Veteran and California National Guard Supplemental Orientation Act of 2023

Requires that each California State University and California Community College campus and requests that each University of California include in transfer and first-year student orientation specified information for students who are veterans and their dependents.

Last Action: Chapter 801, Statutes of 2023

AB 444 (Addis) California Defense Community Infrastructure Program

Creates a state matching grant program to help local communities home to military institutions draw down funds from a federal grant program to enhance and support the areas around those military institutions.

Last Action: Held in Senate Appropriations Committee

AB 475 (Mathis) Sensitive military land: foreign ownership and interests: prohibited foreign actors

Last Action: Died—Filed with the Chief Clerk pursuant to Joint Rule 56

AB 531 (Irwin) The Behavioral Health Infrastructure Bond Act of 2023

Creates the Behavioral Health Infrastructure Bond Act of 2024 to, subject to voter approval, authorize \$6.380 billion in general obligation bonds to finance permanent supportive housing for veterans and others, as well as, unlocked and locked behavioral health treatment and residential settings for individuals experiencing homelessness or at risk of homelessness with severe behavioral health challenges. Allows for by right streamlined, ministerial review for capital projects funded by the bond.

Last Action: Chapter 789, Statutes of 2023

AB 535 (Schiavo)

Prohibits a determination of whether a potential tenant is eligible for supportive, affordable, or transitional housing under the Veterans Housing and Homeless Prevention Act from considering a potential tenant's service-connected disability benefits, and modifies definitions of "secondary tenant" to conform to this exclusion. Last Action: Chapter 918, Statutes of 2024

AB 569 (Garcia) California State University: Cybersecurity: Regional Alliances and Multistakeholder Partnership Pilot Program

Requires the California State University Chancellor's Office, on or before July 1, 2028, to submit a report to the Legislature on the Cybersecurity Regional Alliances and Multistakeholder Partnerships pilot program. Last Action: Chapter 117, Statutes of 2023

AB 684 (Ta) County Veterans Services Officers: Additional Resources

Would provide to any county where there is an active United States military installation a stipend, upon appropriation, for the purposes of maintaining a county veterans service officer, at least part time, on each active United States military base in the county.

Last Action: Died—Filed with the Chief Clerk pursuant to Joint Rule 56

AB 718 (Ta) Veterans Mental Health

Requires the California Department of Veterans Affairs to, establish a program to fund an academic study of mental health among women veterans in California, and to submit a report summarizing the findings and recommendations of the study to the Legislature no later than July 31, 2025.

Last Action: Vetoed by Governor

AB 941 (Waldron) Controlled Substances: psychedelic-assisted therapy.

Requires the California Health and Human Services Agency to convene a workgroup to study and make recommendations on the establishment of a framework governing psychedelic-assisted therapy, as defined. Requires the workgroup to send a report to the Legislature containing those recommendations on or before January 1, 2026. Makes, contingent upon the Legislature enacting a framework governing psychedelic-assisted therapy, the use of hallucinogenic/psychedelic substances for psychedelic-assisted therapy lawful.

Last Action: Held in Senate Health Committee

AB 1014 (Schiavo) Property Taxation: exemption: principal residence: disabled veterans and their unmarried surviving spouses.

Last Action: Died – Filed with the Chief Clerk pursuant to Joint Rule 56

AB 1234 (Davies) Veteran Home Use: Reporting

Last Action: Died – Filed with the Chief Clerk pursuant to Joint Rule 56

AB 1350 (Soria) Veterans: Memorials

Creates the Capitol Park Veterans Memorial Fund, to be continuously appropriated to and administered by the California Department of Veterans Affairs, for the purpose of maintaining and rehabilitating existing memorials in the State Capitol to veterans of the United States Armed Forces. Last Action: Chapter 684, Statutes of 2023

AB 1386 (Gabriel) Veterans Housing; Tenant Referrals

Authorizes entities referring veterans to deeply affordable housing units funded by the Veterans Housing and Homelessness Prevention Program or tax credits and private activity bonds to refer veterans at higher income levels if units are unable to be filled at a lower income threshold for specified time periods.

Last Action: Chapter 760, Statutes of 2023

AB 1462 (Jim Patterson) Veteran Overdose Deaths

Requires the California Department of Public Health to access existing data within the electronic death registration system to compile a report on veteran drug overdose deaths in California and to report specified data. Last Action: Chapter 844, Statutes of 2023

AB 1566 (Soria) Department of Veterans Affairs: Veterans' Services

Requires the California Department of Veterans Affairs' annual report to include the composition of staff at the county office, as specified, and the annual funding of the county veterans service office by the county, as specified. This bill authorizes CalVet to require county veterans service officers to apply uniform measurement of workload units, claims, and other information.

Last Action: Chapter 694, Statutes of 2023

AB 1647 (Soria) Veterans Treatment Courts: Grant Program

Establishes a grant program, upon appropriation, to be administered by Judicial Council to establish and support veterans treatment courts and support veterans in the criminal legal system in counties without veterans treatment courts. Last Action: Held in Senate Public Safety Committee

AB 1665 (Soria) Veterans' Homes

Specifies that dissolution of marriage or termination of domestic partnership does not necessitate the discharge of the spouse or domestic partner; and provides that the discharge of a veteran member who intends to take an aid-in-dying drug, as specified, does not necessitate the discharge of the spouse or domestic partner. Last Action: Ordered to the inactive file at the request of Senator Archuleta

AB 1793 (Ta) Student Financial Aid: Cal Grants: Middle Class Scholarship Program: Eligibility: Dependents of members of the armed services stationed outside of California

Extends eligibility for the Cal Grant and Middle Class Scholarship Program to dependents of a member of the United States Armed Forces who maintains California as their state of legal residence even if the dependent member did not graduate from a California high school and who otherwise meets all other applicable eligibility requirements.

Last Action: Held in Senate Appropriations

AB 1854 (Schiavo) Service Member Protections

Provides for a period following a tour of active duty during which a reservist may apply for relief from specified financial obligations. Last Action: Chapter 144, Statutes of 2024

AB 1882 (Villapudua) Disabled Veterans

Revises eligibility criteria for the disabled veteran's plate and exempts partially disabled veterans, as defined, from paying vehicle registration fees. **Last Action:** Held in Assembly Appropriations Committee

AB 1908 (Schiavo) Department of Veterans Affairs: Internal Audits

This bill requires the California Department of Veterans Affairs to provide an annual report to the governor and legislature on the findings of its internal auditor. **Last Action:** Held in Senate Military and Veterans Affairs Committee

AB 1994 (Assembly Committee on Military and Veterans Affairs) Veterans: Department of Veterans Affairs

This bill creates and requires the secretary to appoint a Deputy Secretary of Minority and Underrepresented Veterans Affairs. Last Action: Chapter 221, Statutes of 2024

AB 2158 (Flora) Vehicles: Disabled Veterans

Last Action: Held in Assembly Transportation Committee

AB 2289 (Low) Vehicles: Parking Placards and Special License Plates for Disabled Veterans and Persons with Disabilities

Authorizes licensed physical therapists to certify a person's disability, beginning January 1, 2026, for purposes of applying to the Department of Motor Vehicles for issuance of a disability placard, license plate, or temporary disability placard, as specified.

Last Action: Held in Senate Appropriations Committee

AB 2306 (Mathis) Sensitive Military Land: Foreign Ownership and Interests: Prohibited Foreign Actors

This bill would require the Military Department to develop statewide policy recommendations regarding ownership and use of real property on sensitive land, as specified, and require the department to submit its recommendations to the Governor and the Legislature

Last Action: Held in Assembly Appropriations Committee

AB 2567 (Mathis) Public Post-Secondary Education: Student Housing: Data Collection: Veterans

This bill expands the information related to campus-owned, campus-operated, or campus-affiliated student housing that California State University and the California Community Colleges are required, and University of California is requested, to post online to also include specified information about veterans. Last Action: Chapter 921, Statutes of 2024

AB 2713 (Hoover) State Parks: Armed Services: Free Access

Requires the Department of Parks and Recreation to grant free access to state parks to veterans, and active duty and reserve members of the U.S. military, who are California residents.

Last Action: Held in Assembly Appropriations Committee

AB 2736 (J. Carrillo) Veterans: Benefits

Eliminates a prohibition against the concurrent receipt and usage of certain federal and state education benefit.

Last Action: Vetoed by Governor

AB 2838 (Davies) Veterans: Memorials

Last Action: Held in Assembly Military and Veterans Affairs Committee

AB 3163 (Mathis) State Parks: Armed Services: Fee Waiver

Expands the authority of the Departments Parks and Recreation to offer reduced fee or free day use of state parks operated by State Parks to veterans, active duty, or reserve military personnel to any additional days State Parks finds appropriate. **Last Action:** Held in Assembly Appropriations Committee

ASSEMBLY MILITARY AND VETERANS AFFAIRS ALL SENATE BILLS YEAR END 2023-24 CALIFORNIA STATE LEGISLATIVE SESSION

SB 73 (Seyarto) Employment Policy: Voluntary Veterans' Preference

Enacts the Voluntary Veterans' Preference Employment Policy Act and authorizes a private employer to establish a veterans' preference employment policy. Last Action: Held in Assembly Appropriations Committee

SB 82 (Seyarto) Property Taxation: Disabled Veterans' Exemption: Eligibility Letters

Requires a county assessor to accept an electronically-generated letter of serviceconnected disability in lieu of an original letter of service-connected disability, at the discretion of the claimant, when verifying eligibility for the disabled veterans' exemption.

Last Action: Chapter 773, Statutes of 2023

SB 228 (Roth) Civilian Youth Opportunities Program

Requires a county assessor to accept an electronically-generated letter of serviceconnected disability in lieu of an original letter of service-connected disability, at the discretion of the claimant, when verifying eligibility for the disabled veterans' exemption.

Last Action: Chapter 703, Statutes of 2023

SB 726 (Archuleta) Property Taxation: Exemption: Disabled Veteran Homeowners

Increases and expands the disabled veterans' property tax exemption for 10 years. **Last Action:** Held in Assembly Revenue and Taxation Committee

SB 783 (Archuleta) Veterans: Suicide

Authorizes the Counties of Los Angeles and Nevada to create a veteran suicide prevention training pilot program.

Last Action: Held in Assembly Military and Veterans Affairs Committee

SB 901 (Umberg) Military: Eligibility

Requires the Department of General Services to develop criteria to evaluate the suitability of state-owned parcels determined or declared excess to be used for affordable housing.

Last Action: Chapter 774, Statutes of 2024

SB 914 (Umberg) Veterans: Employment

Requires that the California Department of Veterans Affairs create and maintain an internet website for matching veterans looking for work with prospective employers. **Last Action:** Held in Assembly Appropriations Committee

SB 916 (Seyarto) Public Post-Secondary Education: Waiver of Tuition and Fees: Veterans: Extended Education Courses

Requires the University of California and the California State University to waive tuition or fees for certain extended education courses for a student who is a dependent of a service-injured veteran, a medal of honor recipient, or a child of a medal of honor recipient.

Last Action: Held in Assembly Appropriations Committee

SB 920 (Seyarto) California Purple Star School Designation Program

Codifies the existing Purple Star School Designation Program, which was established by the California Department of Education in 2022. **Last Action:** Chapter 923, Statutes of 2024

SB 1097 (Laird) Veterans: Military and Veterans: Gender-Neutral Terms

Clarifies existing law exempting National Guard and State Guard members from specified civil obligations, including jury duty, while they are on active duty, and renders gender-specific terminology in several sections neutral **Last Action:** Chapter 129, Statutes of 2024

SB 1138 (Newman) Pupil Attendance: Excused Absences: Military Entrance Processing

Authorizes a student's excused absence due to participation in military entrance processing. Last Action: Chapter 925, Statutes of 2024

SB 1500 (Durazo) Housing: Federal Waiver: Income Eligibility

Prohibits the Tax Credit Allocation Committee and the Department of Housing and Community Development from taking specified punitive actions against affordable housing developments in the City and County of Los Angeles that violate income limit requirements, if certain conditions are met. Last Action: Chapter 491, Statutes of 2024

SB 1529 (Committee on Military and Veterans Affairs) Veterans Homes

Revises and clarifies various veterans' home admission criteria. Last Action: Chapter 140, Statutes of 2024

SB 1530 (Committee on Military and Veterans Affairs) Veterans Homes

Updates outdated statutory language regarding the California Department of Veterans Affairs' veterans' homes member volunteerism program Last Action: Chapter 141, Statutes of 2024

SJR 4 (Ochoa Bogh) Veteran Health Care

Urges the United States Department of Veterans Affairs to locate satellite Veterans Health Administration medical clinics on or near state veterans home campuses and further urges the United States Congress to provide federal funding for the operation of such satellite clinics

Last Action: Chapter 117, Statutes of 2023

SJR 6 (Caballero) Don't Ask, Don't Tell: Discharge Characterization

Urges the President and the Congress of the United States to address, with effective policies, the issue of service members who were unjustly discharged under "Don't Ask, Don't Tell" or previous policies, in order to unify efforts to upgrade discharges issued under the Don't Ask Don't Tell policy and predecessor policies and to restore benefits.

Last Action: Chapter 173, Statutes of 2024
